Williamson County ESD # 7 covers 134 square miles of Northwest Williamson County which includes the City of Florence and the Andice community. 3 highly traveled major highways (SH 195, SH 183, and Ronald Reagan) run through the district. The district is bordered by Georgetown, Jarrell, Liberty Hill, Burnet County, and Bell County. The population of the district is growing at a rapid pace, and we are looking for motivated individuals to grow with us. The district is currently covered by Station 1 in Florence, Station 2 in Andice. Additionally, Station 3 will be built in the Nolina Sub-Division. Currently we are increasing our staff to 6 per shift. We also provide BLS first responder assistance for Williamson County EMS.

Duties of the Probationary Firefighter:

- Perform fire suppression activities utilizing firefighting equipment techniques
- Perform rescue, salvage overhaul operations
- Administer first aid and/or CPR
- Perform housekeeping, building maintenance grounds keeping duties
- Inspect, clean, and maintain assigned apparatus and equipment
- Assist in preparing pre-fire plans, completing reports, and providing training
- Other duties as assigned

- Phase 2- Written Exam
- Phase 3- Physical Ability Assessment
- Phase 4- Interview Panel
- Phase 5- Chief's Interview
