Summary of Discussion from the December 15 Meeting, Related Topics for the Report and Possible Continued Review of House Bill 1593 – The Committee discussed the need to focus on proactive suicide prevention, resiliency, and peer support efforts within fire departments, distinct from reactive response initiatives addressed under housed Bill 35. No action was taken.

 - a. Current overview of the status of suicide prevention and peer support programs in Texas fire departments.
 - b. Licensing and confidentiality concerns related to behavioral health services; and
 - c. Recommendations for legislation and implementation of suicide prevention and peer support group programs.

A motion was made by Amy Ramon and seconded by Lowell Ercanbrack to approve the report format as discussed. Motion carried.

5. Discussion of Possible Recommendations in the Report to the Legislature Related to Suicide Prevention and Peer Support Programs – The Committee discussed potential recommendations to be included in the report, including the training and use of chaplains for suicide prevention. A motion was made by Dr. Susan Gulliver and seconded by John Hosea to approve the recommendation topics. Motion carried.
