#### **Minimum Qualifications:**

- Must be at least 18 years of age at date of application
- High School Diploma or equivalent required
- Texas Department of State Health Services or NR Certified Paramedic
   \*\* Individuals currently enrolled in a paramedic program are eligible to apply.
- Must have a valid Texas Driver's License
- Must pass Physical Agility
- Must pass Psychological Exam
- Must pass Physical Exam
- Must pass Drug Test
- Must be willing to complete Basic Structural Firefighter Academy within 18 months of hire
  - Assignment to firefighting duties would be voluntary
  - Academy would be funded by TCESD1
