# **PHYSICAL AGILITY TEST:**

THE APPLICANT WILL COMPLETE THE PHYSICAL AGILITY TEST WEARING AN SCBA, HELMET AND WORK GLOVES. ALL PERSONAL PROTECTIVE EQUIPMENT IS PROVIDED, BUT THE APPLICANT MAY CHOOSE TO USE THEIR OWN HELMET AND WORK GLOVES. THE APPLICANT WILL HAVE 9 MINUTES TO COMPLETE THE PHYSICAL AGILITY TEST. THERE WILL BE A WALKTHROUGH OF THE PHYSICAL AGILITY TEST PRIOR TO TESTING. THE TIME WILL START WHEN THE APPLICANT LEAVES THE SQUARE AT THE STARTING POINT, AND WILL END WHEN THEY COMPLETE THE LAST STATION.

THE PAT WILL INCLUDE THE FOLLOWING: 24' LADDER CLIMB, PIKE POLE, HIGH RISE PACK, HOSE HOIST, EQUIPMENT CARRY, RESCUE DRAG, KEISER SLED, WEIGHTED HOSE PULL
