City of Mexia Fire & EMS is seeking qualified applicants to fill the position of full-time Firefighter/EMT-B or Paramedic. City of Mexia Fire & EMS is a Full-time career Fire and Emergency Medical Services agency, providing services to residents of Limestone County and the City of Mexia. The service area is 343 square miles on the North side of Limestone County, including the Cities of Coolidge, Mexia, Forest Glade, Lake Mexia, Prairie Hill, Tehuacana and Wortham. The population served by Mexia Fire&EMS is approximately 15,000 persons. In 2022, MFD responded over two thousand (2,200) Fire and EMS incidents in a growing Community.

RESPONSIBILITIES: The Firefighter/EMT-B, is assigned to work Forty eight (48) hour shifts. The Firefighter/EMT-B will be responsible for responses to Fire and Emergency Medical Incidents, public education programs, pre-fire plan surveys, hydrant maintenance, fire station maintenance, and fire apparatus maintenance. Any other duties as required by their supervisor.

REQUIRED QUALIFICATIONS:
Applicant must be at least 18 years of age; a U.S. Citizen; must hold a High School Diploma/GED; must be certified as an EMT-Basic with the state of Texas, Paramedic preferred; must be certified as a Basic Structural firefighter with TCFP; must have or be able to obtain a Texas Class B driver's license within six months; must have an acceptable driving record that complies with current City insurance requirements; must pass a criminal background check; and must pass a physical and drug test.
